

### **History**

This award was established to honor Cornelius G. Dyke, one of the pioneers in Neuroradiology, and is given to an assistant professor, fellow or resident for excellence as demonstrated in a paper, which represents original, unpublished research in some aspect of Neuroradiology.

### **The Dyke Award includes:**

- ★ A \$2,500 honorarium.
- ★ Invitation to present the work at the 46<sup>th</sup> Annual Meeting in 2008.
- ★ Complimentary registration for the 46<sup>th</sup> Annual Meeting in 2008.
- ★ Round-trip coach travel to New Orleans, two nights' lodging and meals.
- ★ Announcement in the *American Journal of Neuroradiology (AJNR)*, posting on the ASNR web site, and mentioned in membership mailings.

### **Application Deadline:**

To be considered for the award, completed manuscripts (including abstracts and scanned Certification Statement) must be received electronically at the ASNR office by **5:00pm Pacific Standard Time (PST), Friday, December 14, 2007**. This award is open to manuscripts submitted to the *AJNR* and/or published since January 1, 2007.

### **Instructions for applying for the Dyke Award:**

Provide the following documents in one electronic file (preferably in .doc format) in the following order:

1. Submit an abstract, which can be downloaded from the ASNR 46<sup>th</sup> Annual Meeting online abstract submission site.
2. Submit a signed Certification Statement (see attachment below). This document is to be scanned and electronically inserted into the packet in the submission process.
3. Prepare a manuscript describing unpublished research work in some aspect of Neuroradiology (head, neck, central nervous system, functional imaging, anatomy, pediatrics or spine).

Submissions must be made by e-mail as one document in the order indicated below:

- 1) abstract,
- 2) scanned Certification Statement, and
- 3) manuscript.

On the subject line of your e-mail, indicate: **DYKE AWARD SUBMISSION**. Manuscripts must conform to the "Authors Instructions" published in the *American Journal of Neuroradiology (AJNR)* and be submitted electronically.
